MINUTES

On a motion by Jeanne Charest, seconded by Nathan Morin, the Board voted to approve the minutes of the May 6, 2021 meeting public and nonpublic sessions. All members voted in the affirmative.

WARRANTS

On a motion by Jeanne Charest, seconded by Nathan Morin, the Board voted to approve the warrants dated May 11, 2021 and May 24, 2021 for the amounts of \$19,238.37 and \$181,069.86. Questions were answered by the Superintendent regarding course reimbursement, out of district costs, and the After School Program. On a roll call vote, all members voted in the affirmative.

FINANCIAL REPORT

The Board reviewed and approved the financial report. Discussion ensued regarding how monies were appropriated from the city and why some years finish with a surplus that is returned to the city.

SPEECH POSITION

AVEC MOU

On a motion by Matthew Buteau, seconded by Scott Losier, the Board voted to extend the current MOU between SAU 3 and SAU 20 regarding open campuses until the end of the 2021-2022 school year. The motion passed unanimously.

- COVID Update - Numbers are stable - 3- Vaccination Clinics mainly for 12-15 year olds will be held at Brown School. A zoom call will be available with Dr. Beals for any parent having concerns or questions on the vaccine.
- The Fair Funding NH group hosted a meeting to allow SAU 3 and SAU 36 Superintendents and School Board chairs to explain their budget struggles with Senator Hennessey before she went into session.
- End of Year Events - trying to get back to normal
- An enhanced summer program is being offered to students at both buildings. This program will focus on academic remediation as well as incorporating fun social activities. It will be funded through ESSER grants. Tammy Fauteux informed the Board of the options being offered at Berlin Elementary School. Mike Kelley informed the Board on credit recovery and running start programs being offered this summer at the Berlin Middle High School.
