- COVID Update - Our community had a few pop up cases, mostly linked to a daycare center. We in NH will follow their best practices including masks being mandated on public transportation. This is really a community issue and we need to get the message out about vaccination to prevent the spread.
- Budget Update - Nothing new to add to the budget.
- Summer Program - Going very well. Thursdays are field trip days and the elementary level has 113 students participating. BMHS has 12-13 different offerings including credit recovery and fun activities such as weight training and wood working.
- New Teacher Orientation- Sandy Pouliot and Sonya L'Heureux will conduct this on August 25, 2021 and will include substitutes.

- Instructional Team Leaders (ITL) and Professional Learning Communities (PLCs) have only one staffing change at each building.


