The Superintendent informed the Board on the following:

- COVID update - 2 Elementary Students and one staff member in isolation. Today's call reported 6 covid patients at AVH; 24 tests done yesterday had 16 come back positive. Vaccinations at Brown School have resumed, with 200 done last week and 400 scheduled for today. The school will hold a vaccination clinic for staff on Friday, November 5, 2021 with 115 scheduled.
- The BMHS roofing project was approved at the November 1, 2021 city council meeting. It will now be submitted for approval to the NH DOE
- Since the last posting we have had 5 new substitute applicants
- Enrollment is down by 36 students. We are reaching out to homeschooled students to see if we can provide services, if that is the case they would be dual enrolled allowing us to retain the student and receive aid. We are also working on updating the homeschool list.


MEMORANDUM OF AGREEMENT
